

**SPECIAL ADDENDUM: COVID-19 POLICIES AND PROCEDURES**

younger) (hereby referred to as "Guest") agrees that, until expressly advised otherwise, they will operate consistent with the following protocols regarding the protection of personnel, other guests, and invitees, Warren Willis Camp & Conference Centers' staff, members, and invitees, and the general public from the spread of COVID-19:

- i) Guest will be free from COVID-19 symptoms prior to entering upon Warren Willis Camp & Conference Center's premises and to immediately report suffering from any symptom related to COVID-19. Symptoms include fever of 100.4 F or higher, dry cough, shortness of breath, chills, loss of taste or smell, sore throat, or muscle aches, or any other symptom identified by the CDC as associated with COVID-19.
- ii) Guest must be symptom free, for at least 72 hours before being permitted to enter upon Warren Willis Camp & Conference Center's premises, of any symptom associated with COVID-19.
- iii) Guest is required, while on Warren Willis Camp & Conference Center's premises, near WWCCC staff, all Personnel and Guests, to wear a mask or face covering or take such other personal protective measures as recommended by the CDC or consistent with other federal, state, or local requirements. This includes practicing social distancing. Masks can be taken off while in the dining rooms eating. Guest shall provide masks or other supplies necessary to comply with applicable guidelines.
- iv) Guest will follow CDC recommended hand washing procedures regularly, throughout the day, using warm running water and rubbing with soap for at least 20 seconds, including immediately after entering upon Warren Willis Camp & Conference Center's premises and before handling any food or drinks to be provided to others.
- v) Guest understands and acknowledges that by entering Warren Willis Camp & Conference Center's premises, the Guest may come into contact with children, families, employees, invitees, members, and other individuals who are also at risk of community exposure to COVID-19. Guest understands and acknowledges that no list of restrictions, guidelines, or practices will remove 100% of the risk of exposure to COVID-19 as the virus can be transmitted by persons who are asymptomatic and before some people show signs of infection. Guest understands that it plays a crucial role in keeping everyone in the Facility safe and reducing the risk of exposure by following the practices outlined above.
